

## **Privacy Policy**

Welcome to the emo-farm.pl website

This website is operated by EMO-FARM Sp. z o.o. (“Bausch Health”, “we”, “us”, or “our”). This Privacy Policy explains how we collect, use, share, and disclose information about you (“Personal Data”) through this website. We process your Personal Data in accordance with applicable privacy and data protection laws within the European Economic Area (EEA) and Switzerland.

### **Collection and Use of Personal Data**

We process Personal Data for various purposes:

- To provide requested services

When you order products online, we collect information such as your identity, contact details, shipping and payment information, and any other data necessary to complete the transaction. You may also create an account on our website to simplify your interactions with us.

- To support our business operations

You may browse this website without providing much personal information. However, our servers automatically collect technical data from visitors for website operation, security purposes, and website performance analysis.

We also use Personal Data internally to improve our products and promotions, manage customer accounts, understand customer needs, and communicate with customers for research and informational purposes.

In addition, we may use your Personal Data in connection with corporate transactions, to protect our rights or property, enforce our legal rights, and establish, investigate, or defend legal claims.

- To fulfill legal obligations

We process Personal Data to comply with tax, accounting, and other legal obligations, including obligations related to commercial transactions. We may also process your data when required by law, court order, or other legally binding decisions.

### **Consent**

In certain situations, we may ask for your consent to collect and use your Personal Data. This may include the use of certain cookies, use of your email address or mobile phone number for marketing purposes, or subscription to specific services such as newsletters. You may withdraw your consent at any time.

You may also voluntarily provide us with Personal Data, including your name, contact details (phone number, email address, mailing address), date of birth, job title, names

and contact details of friends or family members, hobbies and interests, professional affiliations, brand and product preferences, and referral sources.

If you provide information about friends or family members, you are responsible for informing them about this Privacy Policy and obtaining their consent where required.

Individuals under the age of 16 may not provide Personal Data without prior consent from a parent or legal guardian.

We will not use or disclose your Personal Data for purposes unrelated to those described in this Privacy Policy without notifying you first and, where required, obtaining your consent.

### **Sharing of Information**

We may share your Personal Data for the purposes described above with:

- Other companies within the Bausch Health group;
- Service providers supporting our website and business operations, including website maintenance, technology services, payment processing and authorization, and distribution of promotional materials;
- Public authorities, regulatory bodies, law enforcement agencies, and courts where required or permitted by law or binding orders;
- Third parties involved in company restructuring, sale or transfer of assets, mergers, or disposal of Bausch Health or any of its subsidiaries or affiliates.

When transferring Personal Data to countries outside the EEA or Switzerland that do not provide an adequate level of data protection, we implement appropriate contractual safeguards in accordance with applicable data protection laws. ### **Data Security**

We use appropriate technical, physical, and organizational measures to protect Personal Data against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or access.

However, no information security system can guarantee complete security. While we strive to protect your Personal Data, we cannot guarantee protection against unforeseen loss or unauthorized access.

### **Your Rights**

Subject to applicable legal limitations, you have the right to request access to your Personal Data, correction, deletion, restriction or objection to processing, data portability, and the right not to be subject to automated individual decision-making. Requests may be submitted using the contact information provided below.

### **Data Integrity**

We take reasonable steps to ensure that the Personal Data we collect is appropriate for the purposes for which it is used, reliable, and suitable for its intended use, as well as accurate, complete, and up to date.

However, in some cases, we rely on individual users to provide and maintain accurate Personal Data. You are responsible for ensuring that the information you provide to us is current and correct at the time of submission, including when our services allow you to store and manage your personal information.

### **Retention of Personal Data**

We retain Personal Data only for as long as required by applicable law or necessary for the purposes for which it is processed. Personal Data will be deleted once it is no longer needed and, in any case, after the maximum retention period permitted by applicable law.
